The 446-unit serviced residence development – to be known as Fraser Residence Kuala Lumpur (previously known as Project 3KL) is the second 'golden triangle' venture to be announced by Frasers Hospitality, the hospitality arm of property group Frasers Centrepoint Limited. It will be located within the "golden triangle" of Kuala Lumpur, where most international banks, oil and gas companies and multinationals are based.

Fraser Residence Kuala Lumpur will be constructed on a piece of vacant land facing both Jalan Ampang and Jalan Sultan Ismail, next to Renaissance Hotel, is close to two light rail stations and surrounded by entertainment malls, tourist attractions and offices. Fraser Residence Kuala Lumpur comprises two towers with one and two-bedroom serviced apartments. It features a sky gymnasium, infinity lap pool, whirl pool and sauna and is scheduled for completion in four (4) years time.

Fraser Residence Kuala Lumpur is part of a mixed development project in Kuala Lumpur, comprising serviced residences, office suites and also retail mall with a total gross development value of approximately RM550.0 million.

Frasers Hospitality Pte Ltd had signed the first agreement with YNH Property Bhd in July last year for a 217-unit serviced apartment facility to be known as Fraser Place Kuala Lumpur (previously known as 163 Serviced Suites) and is part of a mixed development on Jalan Perak within walking distance of the Twin Towers.

Executive Chairman of YNH, Dato' Dr Yu Kuan Chon, says "This is our second collaboration with Frasers Hospitality after the successful residential development by YNH in Jalan Perak, Kuala Lumpur, now known as Fraser Place Kuala Lumpur. Frasers Hospitality with their global network and expertise will ensure that the management of the building is left in the hands of professionals"
